Business Terms:

The undersigned ("Applicant") hereby makes this Application for Credit ("Application") to PMX Industries, Inc. ("Seller"), and in making this Application the Applicant agrees to be bound by all the terms and conditions contained in this Application, any documents referenced by this Application, or any supplements to this Application. With the respect to any sales of goods or services by the Seller to the Applicant on credit, the Applicant agrees that all amounts payable on or before the stated terms from the date of the Seller's invoice will be paid on or before the date of the invoice plus terms offered. Each of the Seller's invoices will clearly show an invoice date and a statement of terms and if no terms are stated, terms will be net 30 days. Risk of loss shall pass to the Applicant at delivery to a common carrier. No credits will be issued without the Seller's prior written approval, and all returns may be subject to a restocking charge. No terms or conditions of purchase orders different from the terms of the Seller will become a part of any sales agreement, purchase order, or other document unless specifically approved in writing by the Seller.

The parties hereto knowingly and intentionally waive the right to a jury trial on any issue or dispute that may arise between them.

As a result of this application, should a credit availability be granted the Applicant by the Seller, all decisions with respect to the extension or continuation of credit shall be in the sole discretion of the Seller, and the Applicant shall be bound by all of the terms set forth in this Application as well as payment terms on any invoice. The Seller may terminate any credit availability at any time within its sole discretion. If the Applicant is denied credit availability or if there is a denial of a request for an increase in business credit availability, the Applicant has the right to a written statement of the specific reasons for the denial. To

The Seller will send the applicant a written statement of reasons for the denial within 30 days of receiving the Applicant's request for the statement.
